TERMS AND CONDITIONS

The following terms and conditions apply to all workshops, performance and events booked directly with Nonsuch via our website (www.wearenonsuch.com), our box office agent (www.buytickets.at/nonsuch), over the phone or in person. These do not apply to bookings at third party venues, please contact the venue for their own terms.

1. Tickets are issued subject to the Rules and Regulations of Nonsuch. Full details are available on request.
2. Please check your tickets as mistakes cannot always be rectified.
3. The management reserves the right to refuse admission should patrons breach any Rules and Regulations of Nonsuch Theatre.
4. The management may on occasions have to conduct security searches to ensure the safety of the patrons. Every effort to admit latecomers will be made at a suitable break in the event, but admission cannot always be guaranteed.
5. We regret that tickets cannot be exchanged or refunded after purchase. The Management cannot be held responsible for any tickets which are lost or stolen. Nonsuch Theatre reserves the right to cancel ticket bookings which it reasonably suspects to have been made fraudulently.
6. Workshop bookings, regular outreach sessions, residencies, youth theatre, CPD or other outreach based event cannot be refunded under any circumstance unless the event is fully booked and another individual takes on your committed place.
7. Tickets are sold subject to the management's right to alter or vary the programme due to events or circumstances beyond its control without being obliged to refund monies or exchange tickets.
8. The unauthorised use of photographic and recording equipment is prohibited. Tapes or films may be destroyed. Laser pens, mobile phones, dogs (except guide dogs) and patron's own food and drink are also be prohibited (patron's own food and drink are permitted in workshop environments).
9. The Management accept no responsibility for any personal property.
10. The Ticket holder has a right only to a seat of a value corresponding to that stated on the ticket and the Management reserve the right to provide alternative seats to those specified on the ticket.
11. Ticket holders consent to filming and sound recording as members of the audience.
12. If a performance is rescheduled, ticket holders will be offered tickets to the rescheduled performance, equivalent to the face value of the ticket.
13. All of these terms and conditions are governed by English Law.
14. The ticket holder must comply with all relevant statutes, safety announcements and venue regulations whilst attending the event.
15. Breach of any of these conditions or any unacceptable behaviour likely to cause damage, nuisance or injury shall enable the Theatre management to eject you from the venue.
16. For web and telephone sales for non-date related products (i.e. gift vouchers and merchandise but not tickets), a customer will have a 14 days in which to cancel the item and the box office will provide a refund.
